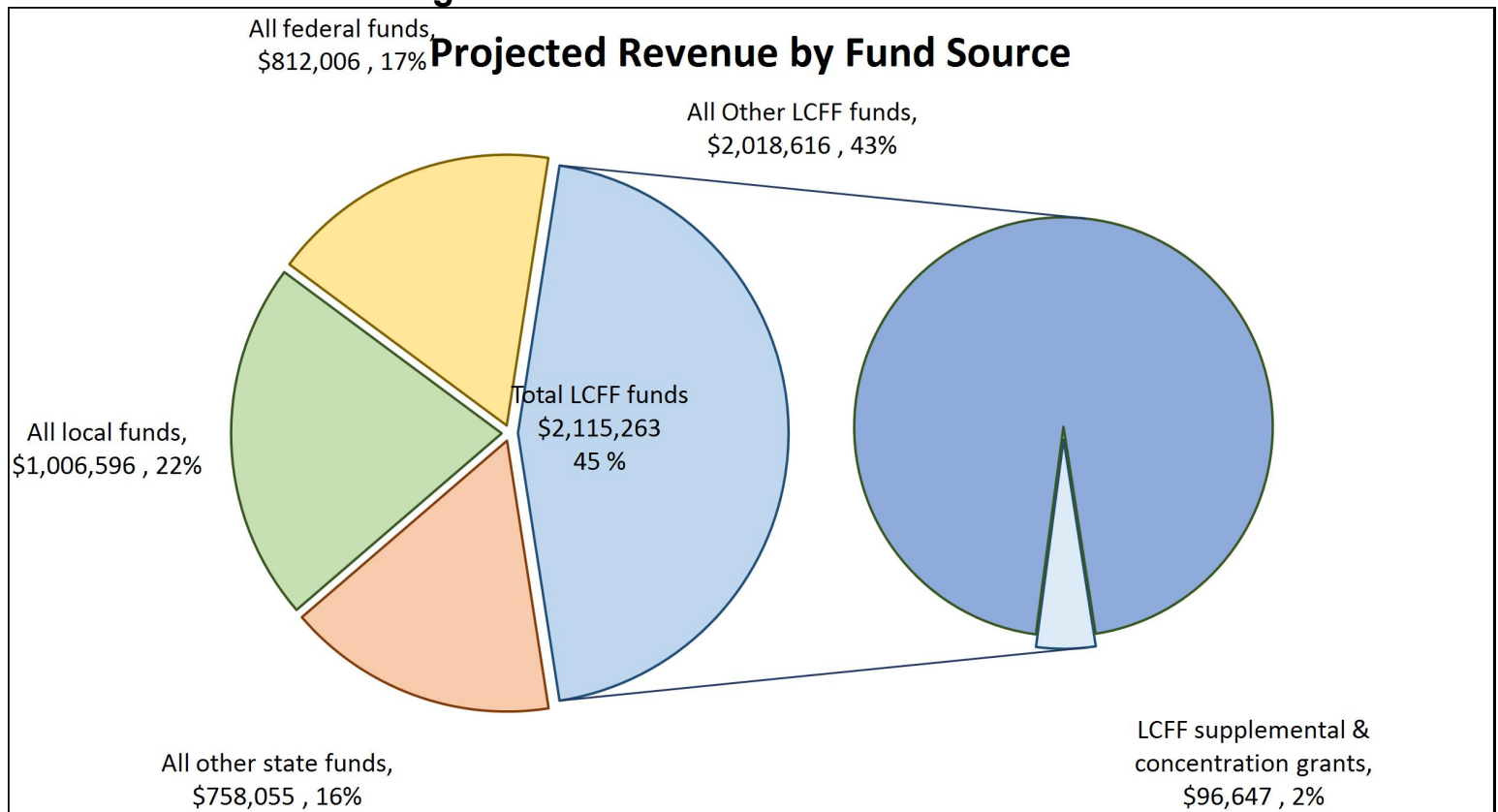

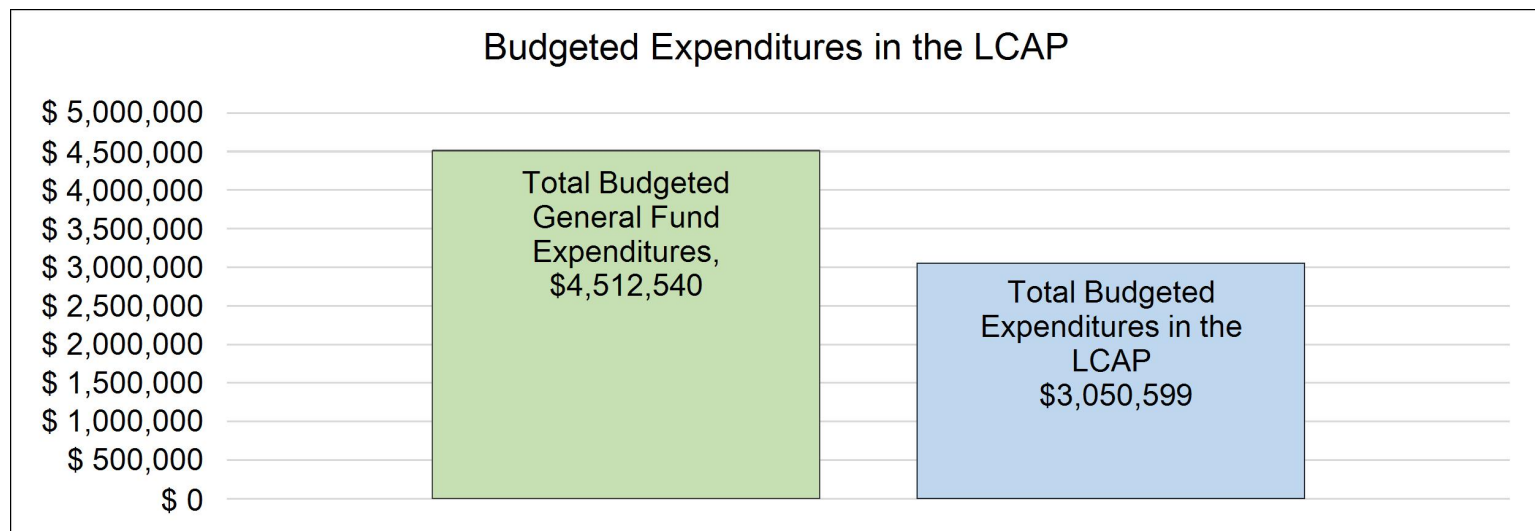


This chart shows the total general purpose revenue Orange County Academy of Sciences and Arts expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Orange County Academy of Sciences and Arts is \$4,691,920, of which \$2,115,263 is Local Control Funding Formula (LCFF), \$758,055 is other state funds, \$1,006,596 is local funds, and \$812,006 is federal funds. Of the \$2,115,263 in LCFF Funds, \$96,647 is generated based on the enrollment of high needs students (Foster Youth, English learner, and low-income students).

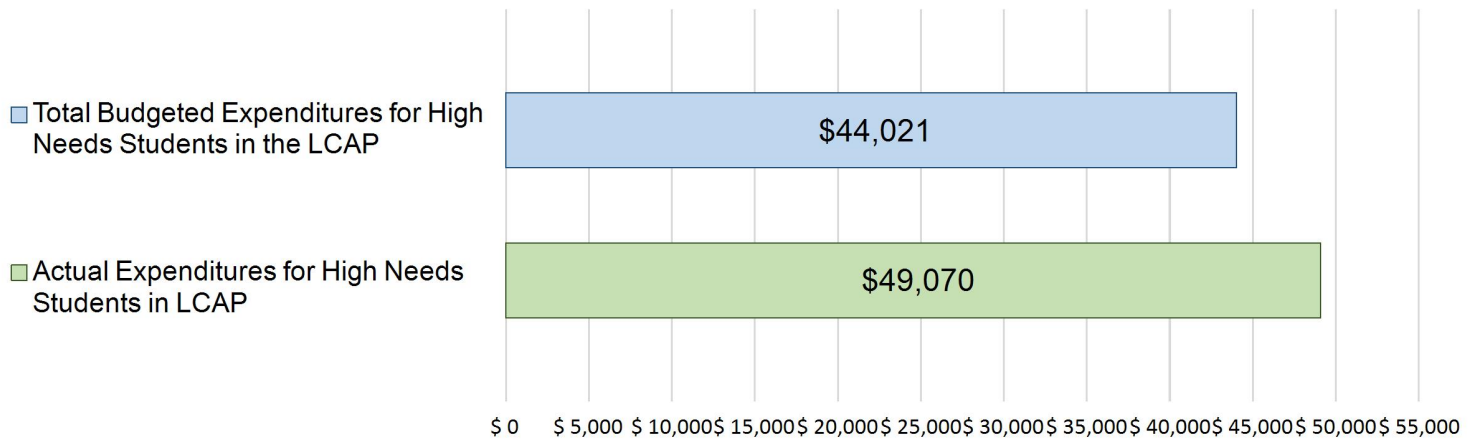

Plan Summary [2026-27]

General Information

OCASA III will serve grades TK-8 in the 2026-27 school year across two sites. The OCASA educational program focuses in four core areas: high quality instructional program, personalized learning, STEAM+ experiences for all students, hands-on learning.

In 2025-27, OCASA III will add TK-5 and will focus on the implementation of core curricula (EL Education, IM, Open Sci Ed, Investigating History), using multiage groupings to tailor learning to a continuum of student need. Students in K-5 will receive Project Lead the Way modules throughout the year and the teachers will plan embedded projects that align with core curricula and standards.

In 6-8, OCASA III will continue to use the Gradient platform to allow for student access and feedback for all courses. Students will also have access to Project Lead the Way courses and embedded projects throughout the semester and year. Students receive biweekly mentoring with an assigned teacher to ensure they are setting and achieving personalized learning goals.

OCASA III will serve a diverse population of students and in 2025, estimated to be 41% being white, 32% Hispanic/Latino, 35% students with disabilities, 42% socioeconomically disadvantaged.

The purpose of this Local Control Accountability Plan (“LCAP”) is to address the School Plan for Student Achievement (“SPSA”) for OCASA which is the Schoolwide Program; herein referred to as the LCAP. The Charter School’s plan is to effectively meet the ESSA Requirements in alignment with the LCAP and other federal, state and local programs. The plans included in the LCAP address these requirements compliant to include focusing on three goals: GOAL 1: OCASA students will engage in rigorous, differentiated instruction to ensure each

student can achieve to his/her fullest potential. GOAL 2: OCASA will create a positive school climate. GOAL 3: OCASA will engage and involve parents. Each goal includes actions and services that address the needs of all students and significant subgroups which include evidence-based strategies that provide opportunities for all children, methods and instructional strategies, and particular focus on students at risk of not meeting the State academic standards.

OCASA III is not eligible for Equity Multiplier funding.

Parents and staff shared feedback on a survey administered by the school in March 2026. The survey was followed by a deeper level of engagement via chats with the principal.

The parent survey indicated that families were satisfied with the program that OCASA Middle School offered this year with strengths being: access to standards-aligned courses and curriculum, students feeling connected to their learning and the school, and school culture. Access to broad courses and experience is an area of growth based on parent feedback.

- **5. Total Planned Percentage of Improved Services**
 - This percentage is the total of the Planned Percentage of Improved Services column.
- **Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)**
 - This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

- **Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)**
 - This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- **10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)**
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**

- If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9).
