




This chart shows the total general purpose revenue Orange County Academy of Sciences and Arts expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Orange County Academy of Sciences and Arts is \$4,656,056.00, of which \$2,958,222.00 is Local Control Funding Formula (LCFF), \$709,381.00 is other state funds, \$455,530.00 is local funds, and \$532,923.00 is federal funds. Of the \$2,958,222.00 in LCFF Funds, \$110,503.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



# **Plan Summary [2025-26]**

### **General Information**

Orange County Academy of Sciences and Arts ("OCASA") is an independent K-5 charter school located in Laguna Niguel. The community of families chose OCASA due to their desire for a different learning environment and experience for their students. OCASA accomplishes this through hands-on, inquiry-based instruction and Individualized Learning Plans ("ILPs") which are designed to meet the learning needs of every student. These plans are developed by analyzing data from formal and informal assessments, SBAC data, ELPAC data, through interactions with the students, and feedback received from families during conferences. Inquiry Arcs will provide the foundation for a rich learning experience at OCASA. Each Arc will last an entire semester and include three phases – exploration, expression, and exposition. These phases are based on the approach that Brightworks School SF uses (developed by Gever Tully).

OCASA is a school for children between Kindergarten and 5th Grade, placing an emphasis on the academic, social and physical development of children in the areas of Science, Technology, Engineering, Arts and Mathematics. OCASA will provide an education that respects the development of the child by using proven pedagogy applied by an experienced and friendly team. The school will provide an environment that is welcoming of students and their families to learn in harmony with an environment that favors a multi-cultural spirit and awareness of the world we live in.

In 2023-24, OCASA served 223 students with the following demographics: 3.1% English Learners, 22.9% Socioeconomically Disadvantaged, 9.4% Disabilities. 53.4% of students were white, 1% African American, 4.5% Asian, 1.8% Filipino, 15.7% Hispanic/Latino, 16.1% two or more races. Of these subgroups, SED students, Hispanic/Latinx students, students of Two of More races, and White students are significant

subgroups; however, OCASA addresses specific actions and services for ELs and FY students to provide equal access to a high-quality program.

The purpose of this Local Control Accountability Plan ("LCAP") is to address the School Plan for Student Achievement ("SPSA") for OCASA which is the Schoolwide Program; herein referred to as the LCAP. The Charter School's plan is to effectively meet the ESSA Requirements in alignment with the LCAP and other federal, state and local programs. The plans included in the LCAP address these requirements compliant to include focusing on three goals: GOAL 1: OCASA students will engage in rigorous, differentiated instruction to ensure each student can achieve to his/her fullest potential. GOAL 2: OCASA will create a positive school climate. GOAL 3: OCASA will engage and involve parents.

This spring, we completed a needs assessment across the organization which included an analysis of verifiable state data and local performance data used to measure student outcomes as evidenced in the annual update portion of the LCAP. The needs assessment process included soliciting feedback from parents, classified staff, teachers and administrators to identify areas of opportunity for the students and groups of students who are not achieving standard mastery and to identify strategies which will be implemented in the LCAP to address those areas of opportunity.

Each goal includes actions and services that address the needs of all students and significant subgroups which include evidence-based strategies that provide opportunities for all children, methods and instructional strategies, and particular focus on students at risk of not meeting the State academic standards.

### **Reflections: Annual Performance**

2024 Strengths and challenges:

- -OCASA Elementary scored at the highest level (Blue) in ELA and Math on the 2024 Dashboard. This was the result of high achievement and high levels of year over year positive change in CAASPP scores. Less than 1% of students were suspended and internally collected survey data showed high levels of parent satisfaction with the program.
- -Challenges include communication and creating effective systems to sustain success.

Parents shared that OCASA Elementary has strengths in employing high quality teachers, the quality of the educational program, staff making them feel welcomed, and providing access to discussing concerns with teachers. Parents indicated that they would like more ongoing ways to provide feedback and more communication with school leadership.

Via surveys and feedback meetings, staff (inclusive of teachers and administrators) also shared that the quality of the program and team were strengths. Areas of growth included: increasing support for students with disabilities, improving facilities, and overall communication.

In response to this feedback, more specific actions are allocated to Goal 1 Action 5 (Special Education) this year. With families, communication will be a high priority in the coming school year and is reflected in Goal 3, specifically Action 1.
