

General Information about the School Accountability Report Card (SARC)

SARC Overview



By February 1 of each year, every school in California is required by state law to publish a School Accountability Report Card (SARC). The SARC contains information about the condition and performance of each California public school. Under the Local Control Funding Formula (LCFF) all local educational agencies (LEAs) are required to prepare a Local Control and Accountability Plan (LCAP), which describes how they intend to meet annual school-specific goals for all pupils, with specific activities to address state and local priorities. Additionally, data reported in an LCAP is to be consistent with data reported in the SARC.

Internet Access

Admission Requirements for the University of California (UC)

Admission requirements for the UC follow guidelines set forth in the Master Plan, which requires that the top one-eighth of the state's high school graduates, as well as those transfer students who have successfully completed specified college course work, be eligible for admission to the UC. These requirements are designed to ensure that all eligible students are adequately prepared for University-level work. Admission Requirements for the California State University (CSU)

Eligibility for admission to the CSU is determined by three factors: (1) Specific high school courses, (2) Grades in specified courses and test scores, and (3) Graduation from high school. Some campuses have higher standards for particular majors or students who live outside the local campus area. Because of the number of students who apply, a few campuses have higher standards (supplementary admission criteria) for all applicants. Most CSU campuses have local admission guarantee policies for students who graduate or transfer from high schools and colleges that are historically served by a CSU campus in that region. 2025-26 School Safety Plan

OCASA III has developed a Comprehensive School Safety Plan (CSSP) designed to provide a safe and orderly environment for students, staff, and visitors. The plan was developed in collaboration with school faculty and local law enforcement to

ensure all campus-specific needs are addressed. The safety plan was last reviewed, updated, and discussed with school faculty in August 2025.

The key elements of the CSSP include protocols for various emergency situations such as fire, earthquake, and lockdown procedures. It also outlines the school's "Safe School Plan," which covers disaster procedures, child abuse reporting, sexual harassment policies, and procedures for safe ingress and egress of pupils and staff. To ensure readiness, the school conducts regular safety drills, including monthly fire drills and biannual earthquake and lockdown practices, allowing students and staff to become familiar with emergency routes and response expectations.

The school also emphasizes a proactive approach to safety through a positive school climate and mental health support. Our plan includes procedures for identifying and supporting students who may be experiencing social-emotional challenges, as well as clear guidelines for maintaining a campus free from bullying and discrimination. The CSSP is a living document that is reviewed annually to incorporate updated best practices and feedback from our school community.

OCASA III utilizes its funding to provide a robust suite of services designed to support the academic and social-emotional growth of every student. Central to our model is a comprehensive Multi-Tiered System of Supports (MTSS), which includes dedicated student services staff providing both push-in and pull-out support daily. These funds support an academic counselor who works directly with students to provide mental health resources and facilitate small-group interventions for those needing

additional academic or behavioral assistance.

In addition to core academic support, the school funds various specialized programs that enrich the student experience and foster a well-rounded education. Faculty members participate in collaborative planning sessions designed to refine their lesson planning skills, ensuring that every inquiry-based investigation is both academically rigorous and engaging for students.

A key pillar of our PD program is the intentional use of data to drive instructional decisions. Teachers are trained to analyze various student performance and engagement metrics to identify individual needs and tailor their instruction accordingly. This data-informed approach is complemented by ongoing training in Social-Emotional Learning (SEL) and inclusionary practices within our Multi-Tiered System of Supports (MTSS). These professional growth opportunities are delivered through a combination of full-day workshops, weekly collaborative sessions, and targeted mentorship, all aimed at fostering a positive and academically stimulating environment.
